BACKGROUND

After ten years as a solicitor in the City of London specializing in the laws of trusts and taxation, I took advantage of my training and experience to start an education charity. I established the charity in Tanzania and then in Rwanda. My legal skills have played a large part in the charity's success. Twenty-five years later, through many varied challenges, that charity, Education East Africa, is still going strong.

I have demonstrated the ability to conceive projects, set them up from scratch, pay attention to every detail, and pursue them with fortitude. In both Tanzania and Rwanda my work has gained the recognition of senior government officials, and in Tanzania I had a private audience with President Jakaya Kikwete. Indeed, my work in Tanzania was recognized with the award of an MBE in 2001.

Through hard work and with tenacity I have developed an exceptional method of educating children and teachers in rural primary schools. This is the fruition of working in rural primary school classrooms, getting to know the teachers and the constraints in their work, examining and analyzing primary school curriculum, reporting and presenting to officials, writing and adapting textbooks and teaching materials, overseeing the translation of materials, coordinating the printing and publishing of books, gaining permission for pilot projects, leading the projects, monitoring and evaluating them and demonstrating their success.

Unwavering from my principle that government primary education can and should be improved, despite the lack of available funding, I champion the cause of the disadvantaged child.

Not only do I have a unique understanding of Africa, I also have the experience of having lived most of my professional life abroad in challenging places with different cultures and diverse people.
